Regular combat report

1. Eight 82 mm mortar shells were fired on positions in the Sudić Planina sector between 1230 and 1310 hours. Our forces in the /Gosineli/ sector came under strong 12.7 mm PAM /anti-aircraft machine-gun/ fire from the Renovica sector at 1430 hours.
2. Our forces are engaged in defending the zone of responsibility of the brigade. In that respect, intensive reconnaissance of the enemy on the Žepa axis continued, where two Muslim soldiers were killed yesterday in an ambush in the Brezov /?/ sector and one soldier was wounded on the Goražde axis in the Gosina Planina sector. A part of the forces is engaged in securing the supply routes and uncovered gaps. The unit in the reserve the strength of a reinforced platoon is still engaged in searching the terrain on the Goražde axis and finding remaining enemy groups and crushed enemy forces which were infiltrated on 2 June 1995.
3. Ukrainian convoy no. 07-012/07 comprising three vehicles from Sarajevo to Žepa passed through the checkpoint in Rogatica. A UNHCR convoy from Karakaj to Žepa, which arrived at the checkpoint yesterday, is still in Rogatica undergoing a detailed search since ammunition for infantry weapons was found yesterday.

4. Combat morale is at the necessary level, despite continuous engagement without rest or rotation.
5. There was no consumption of large calibre ammunition during the day and consumption of fuel for the execution of regular combat was 250 /handwritten: litres/ of diesel and 25 l of petrol.
6. We did not sustain any casualties; there were no cases of desertion.
